Scalping Trading

Scalping in Forex/CFD trading is a trading style that traders utilize to benefit from minor price changes during a short period. In **MasterMind Capitals Ltd** client agrees, the definition of Scalp trading transactions is when traders enter and exit positions in less than **90 seconds** on **Foreign Exchange** and **Spot Metals**, and within **300 seconds** on **CFD** Contracts (Including single name **Stocks, Equity Indices, Future Metals, Crypto Currencies & Crypto CFDs**).

Arbitrage Trading

Arbitrage Trading refers to the practice of buying & selling of the same assets / pairs / currencies simultaneously in different markets or with different brokers to take advantage of price differences and make a profit. Traders exploit inefficiencies in prices between markets, exploiting the price differential for the same asset / pairs / currencies.

Under no circumstances will **MasterMind Capitals Ltd** accept any sort of arbitrage trading which includes but is not limited to, **Latency Arbitrage**, **Spot – Futures Arbitrage**, **Gold / Silver Arbitrage**.

If **MasterMind Capitals Ltd** finds out that any particular account is carrying out any arbitrage trades, upon investigation that particular trading account will be blocked and no withdrawals will be given out for the particular trading account.
